## Expansion of the fast tracking listing process to the Court at Heidelberg and Melbourne

### Background

It is well known with family violence cases that the rate of recidivism for crimes of violence against intimate partners is much greater than crimes of violence against strangers. Accordingly, the Magistrates' Court of Victoria (the Court) has commenced the introduction in stages of a fast tracking listing process of these cases. The first stage commenced at the Court at Dandenong on 1 December 2014.

The purpose of this Practice Direction is to expand the process to two further venues of the Court.

### **Direction**

- 1. As and from 2 January 2017, all criminal charges arising out of family violence incidents and filed in the Court at Heidelberg and the Court at Melbourne will be listed according to the timelines:
  - (a) Where the accused person is on bail, from the date of his or her release on bail to the first listing of those charges one week;
  - (b) Where the accused person has been summonsed, from the date of the interview to the first listing four weeks;
  - (c) In either case described in (a) or (b):
    - i. From the date of the first listing to the date of the second listing

       four weeks;
    - ii. From the date of the second listing to contest mention four weeks<sup>1</sup>;
    - iii. From the date of the contest mention to trial four weeks.

<sup>&</sup>lt;sup>1</sup> In some instances, a proceeding may be adjourned for trial without a contest mention. Whether that occurs is a matter for the presiding magistrate.

- 3. At the time of release on bail or when served with a summons, the accused person must be given a document entitled "Family violence related criminal proceedings", a copy of which is attached to this Practice Direction.
- 4. This Practice Direction commences on 2 January 2017.

# Family violence related criminal proceedings Information for accused persons

If you have criminal charges listed at the Court at Heidelberg or Melbourne that are family violence related, the following listing timeframes will apply:

| Filing to first listing for <b>bail</b> matters (the time to first listing from the release of an accused on bail) | 1 week  |
|--|---------|
| Interview to first listing for summons' matters  | 4 weeks |
| First listing to second listing (a summary case conference is to be conducted on or before the second listing)     | 4 weeks |
| Second listing to contest mention  | 4 weeks |
| Contest mention to contested hearing   | 4 weeks |

### **Adjournment Requests**

The Court may grant a short adjournment from the first listing if suitable or sufficient reasons are supplied. You and/or your legal representative **must** be present at court for any future adjournment request to be considered. If you are on bail, you **must** appear at court for each listing.

### **Police Brief**

If you do not have a copy of the preliminary brief at the first listing, you will need to obtain a copy from Victoria Police prior to leaving the court. You will need to provide a copy of the brief to your legal representative.

### **Summary Case Conference**

A summary case conference will need to occur on or before the second listing date.

### Legal Advice

It is very important to get legal advice before you go to court. Legal advice will help you:

- decide if you will say that you are guilty or not guilty
- · decide if you need a lawyer to speak for you in court or if you can represent yourself
- help you to prepare for your case
