Practice Direction 9 of 2013

Applications made under the Fortification Removal Act 2013

Background

The Fortification Removal Act 2013 commenced on 6 October 2013. Although, this Act introduces a number of applications, notices and orders, there is currently no intention to prepare any relevant regulations. In addition to this, Court Rules have not yet been drafted. This Direction will assist the Court in establishing the process and forms to be used when applications are made pursuant to section 6 of this Act.

Direction

Any application for an order for the removal or modification of fortification must be made in accordance with section 7 of the Fortification Removal Act 2013.

These applications must be filed with the Court, using the attached form 'Application for Fortification Removal/Modification Order' (ATTACHMENT 1). Once filed with the Court, the application will be listed no sooner than 28 days from the filing date.

In accordance with section 9 & 29 of this Act, objections may be filed by the owner and/or occupier of the premises subject of the application. Objections must be made using the attached 'Objection to Fortification Removal Act Orders' form (ATTACHMENT 2).

Once a magistrate has determined the application, the police applicant or their legal representative must file a copy of the order made, for signing and sealing by the Court.

Other applications relevant to this Act, must be filed using the forms attached to this Practice Direction including, 'Application for Extension of Compliance Period' (s19) (ATTACHMENT 3), and 'Application for Entry and Inspection Order' (s26) (ATTACHMENT 4).

All applications made under this Act are to be filed at the Melbourne Magistrates' Court unless directed otherwise.
