**TCS - 'Litigation Guardian' Software Users** will need to update their fee tables. To do this log on to Litigation Guardian as a 'MANAGER' or 'MASTER', select the Maintenance Menu and the 'Edit Fee Table' option. Modify each fee by double clicking on it and then typing in the new amount from the above table. Use either the 'Browse' button or the navigational arrows to move between the different scales.
