

Your Family Violence Court Hearing

IMPORTANT INFORMATION FOR COURT USERS

Issued June 2021

What do I need to do?

You <u>must</u> contact us **three business days** before your hearing to help us prepare your case for court. The information you provide will ensure that we have your current contact details and that we can connect you with legal and support services to help you prepare for court.

If you do not contact us before your hearing day, the court can hear your matter in your absence.

How do I complete the form?

Otherwise, you can:

- complete the attached pre-court information form and provide it to the court where your case is listed
- call or email the court where your matter is listed. You can find the contact details for your local court on our website www.mcv.vic.gov.au.

Do I need to come to court for my hearing?

The court will decide how you participate in your court hearing. In most cases, the **respondent** (the person the applicant is against) must take part in the court hearing in person. **Affected family members** (the person protected by the order) can choose how they want to take part in the court hearing.

The court must comply with public health directions issued by the Chief Health Officer, and this may affect how you participate in your hearing. Check the <u>Magistrates' Court of Victoria website</u> for the latest advice on attending court.

Should I get legal advice?

You are encouraged to get legal advice before your court hearing. The following legal services may be able to provide some free legal advice, or you can contact a private lawyer in your area:
